LEGAL DEPOSIT

ENSURING PUBLICATION PRESERVATION AND
ACCESS TO ALL NEW ZEALANDERS

The National Library of New Zealand is required to collect, preserve and make available the documentary heritage of New Zealand.

Under legislation* all publishers in New Zealand are required to deposit their publications with the National Librarian.

Legal Deposit covers both print and electronic publications, and applies to books, magazines, maps, newsletters, CDs, DVDs, internet documents, e-publications, pdfs and many other types of publications released or made available to the public.

Two copies of physical publications should be sent to the Legal Deposit Office.

One copy of an electronic document should be emailed to electronic-legal-deposit@dia.govt.nz.

One copy of each physical publication will remain in the collections of the Alexander Turnbull Library perpetually. The second copy is made available to the public through the Library's General Collections. Electronic publications are permanently preserved in the National Digital Heritage Archive.

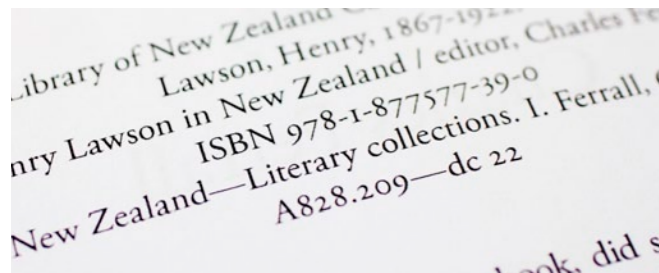
INTERNATIONAL STANDARD NUMBERS

A PUBLICATION'S 'FINGERPRINT'

The National Library of New Zealand is responsible for allocating International Standard Numbers for publications – books, serials and music – in New Zealand.

All standard numbers can be requested using forms available on the National Library website.

A number is issued for each format of a publication (e.g. print paperback, hardback, CD-ROM, or online pdf).



INTERNATIONAL STANDARD BOOK NUMBERS (ISBN)

A 13 digit unique identifier number assigned to books and other print, electronic, or multimedia publications.

An ISBN is a book's 'fingerprint' that allows publishers, book suppliers and libraries to easily locate and order it. The ISBN can be incorporated in the book's barcode.

It is used for printed books and pamphlets containing more than four pages of text, maps, e-books, pdfs, Braille publications and audio books.

Publishers issuing large numbers of publications can be given a block of numbers, which they use as required.

INTERNATIONAL STANDARD SERIAL NUMBERS (ISSN)



An ISSN is an 8 digit unique identifier number assigned to the title of a periodic publication issued in successive parts, identified by a number and/or a date, linked by a common title, and intended to continue indefinitely.

It is used for magazines, newspapers, journals, annual publications (annual reports, yearbooks and directories), and monographs-in-series (publications that have an individual title and a common title that links them together in a series).

Serials can be published in physical or electronic formats.

Serials do not include loose-leaf publications intended to be updated (e.g. manuals where the instructions constantly change and are updated).

INTERNATIONAL STANDARD MUSIC NUMBERS (ISMN)

A unique identifier number applied to printed music, such as a score or a part.



CATALOGUING IN PUBLICATION (CiP)

A CATALOGUE RECORD IS CREATED BEFORE PUBLICATION

The Cataloguing in Publication (CiP) programme is for all publishers in New Zealand – from small, medium and large commercial publishers, to self-publishers.

The record includes (where applicable): the title, author, series, subject, Dewey classification, and the proposed date of publication.

We can supply a copy of the completed catalogue record that can be printed in the book itself, and used by libraries in their own catalogues.

The record is also added to the New Zealand National Bibliography (Publications New Zealand), where it can alert libraries, universities and book sellers to the existence of upcoming titles.

Once the Legal Deposit Office has received the book the catalogue record is upgraded to a full catalogue entry.

PUBLIC LENDING RIGHT FOR NEW ZEALAND AUTHORS SCHEME

The Public Lending Right scheme compensates New Zealand authors for the use of their books in New Zealand libraries.

A fund is distributed annually based on a survey of books held in New Zealand libraries. If it is estimated that an author has 50+ copies of their title in New Zealand libraries they receive a proportion of the fund.

In order to be eligible for payment, an author must register with the scheme each year between 1 January and 30 April. Any payment owing is made in mid-December.

COPYRIGHT PROTECTING YOUR RIGHTS

Copyright is a protection granted automatically in New Zealand from the time a work is created. It is separate from Legal Deposit.
